For the 2019 Community Health Needs Assessment (CHNA), the hospital has defined their community to be the geographical area of Collin, Dallas, Denton, Ellis, Henderson, Hunt, Kaufman, Navarro, Rockwall, Tarrant, and Van Zandt counties. The community served was determined based on the counties that make up at least 70 percent of each hospital's inpatient and outpatient admissions.

Charity Care

Government Sponsored Programs

Unreimbursed expenses associated with providing medical care to the beneficiaries of Medicare and other federal, state or local government health care programs.
